

Address reported and billing priority level in the header; all critical items will be highlighted in red

- Top box will hold all items needed from the family
- Middle box will hold copies received by the family w/a 'rejected' or 'approved' stamp
- Bottom box will tell you which 2 Proofs of Residency have been received & approved. NOTE: Families who moved more than 30 days ago will need to provide 2 separate Proofs of Residency. What is "current" today may not be "current" tomorrow.

For example, a family provides a water bill that shows the last day of *delivery* in the billing cycle was 02.17.2024.

Today is 03.11.2024; after 03.17.2024, this bill is no longer "current".

Top box can be used for communication between CA Dept and Family Coaches.

NOTE: Once you click on Add to Notes, you'll be directed away from this screen. Try to save this step until after you are finished reviewing this student's info

Bottom box is where all previous notes are stored; the most recent being listed first, at the top
